Income:

- * [Emergency General Assistance \(EGA\)](#) - Help to resolve a one-time crisis that immediately threatens a basic health or safety need (such as food, shelter or utilities)
- * [General Assistance \(GA\)](#) - Cash assistance to help cover basic needs for people who can't work and who do not have children in their home
- * [Minnesota Family Investment Program \(MFIP\)](#) - Helps families in poverty with children through a cash grant, food assistance and employment services
- * [Minnesota Supplemental Aid \(MSA\)](#) - Money to help pay for basic needs of people with very low incomes and limited assets
- * [Refugee Cash Assistance \(RCA\)](#) - Provides money to newly arrived refugees who are making the transition to life in the United States and are not eligible for Supplemental Security Income (SSI) or Minnesota Family Investment Program (MFIP)
- * [Diversionary Work Program \(DWP\)](#)

Food:

- * [Minnesota Family Investment Program \(MFIP\)](#) - Helps families in poverty with children through a cash grant, food assistance and employment services
- * [SNAP - Food Support](#) - Helps people with low income buy food
- * [Women, Infants and Children \(WIC\)](#) - Nutrition program for eligible low income pregnant women, new mothers, babies and young children to eat well, learn about nutrition, and stay healthy

Health Care:

- * [Emergency Medical Assistance \(EMA\)](#) - Covers the cost of emergency medical care for people with low-incomes who are not United States citizens
- * [MA for Employed Persons with Disabilities \(MA-EPD\)](#) - Work incentive that allows people with disabilities to work and keep their Medical Assistance (MA)
- * [Medical Assistance \(MA\)](#) - Minnesota's Medicaid program that provides health care coverage to low-income children, families, pregnant women,

* [Medical Assistance - TEFRA Option for Children with Disabilities](#) - An insurance option for children with disabilities who live with their parent(s), need a high level of care, and whose parents have too much income for their child to qualify for MA

* [Medicare Savings Programs - SLMB, QMB, QI and QWD](#) - Programs help people on Medicare who have low-to-modest incomes to pay for Medicare premiums and sometimes other Medicare costs

* [Refugee Medical Assistance \(RMA\)](#) - A Minnesota Health Care Program (MHCP) that provides up to eight months of health care insurance coverage to refugees with low income

* [MinnesotaCare](#) is a health insurance program for Minnesotans with low incomes.

* [Consumer Directed Community Supports \(CDCS\)](#) - Allows participants in MN waiver programs or Alternative Care to manage their own services and supports

* [The Family Support Grant \(FSG\)](#) - A state program that helps families of children and young adults with disabilities to pay for disability-related items and services.

Housing:

* [Emergency Assistance](#) - provides one time financial help to pregnant women or families with minor children who face a housing crisis.

* [Housing Assistance](#) - Helps pay housing-related expenses for people with low income who are 65 years or older, or are 18 years or older and have a disability that prevents them from working enough to support themselves. People can receive Housing Support from an eligible provider if they live in an eligible place, which could be a licensed facility or a person's own home.

* [Minnesota Housing Support](#) (formerly known as Group Residential Housing - GRH) program.

Protective Services:

- * [Child protection Services](#) - Responds to situations where children are alleged to be maltreated and helps support families to safely care for their children.
- * [Adult Protective Services](#) - Assesses needs and provides emergency and continuing services to safeguard the welfare of vulnerable adults. Examples of adult protection activities include assisting the vulnerable adult to move, apply for social or financial services, or initiate proceedings related to guardianship or conservatorship.
- * [Adult Protective Services](#) - agencies investigate reports of maltreatment of vulnerable adults when the suspect is a family member, friend, or stranger not related to a program or service licensed by the Minnesota Department of Health or the Minnesota Department of Human Services (DHS).
