**Call to Order:** 12:10 p.m.

**Debriefing on:**

- **Elected Officials Forum:** The forum went very well with great participation from elected officials and a good turnout from the public. Following the event, every group that was represented at the forum sent a thank you to Lynn for being invited to participate in the event. Stephanie did an excellent job as moderator and Sue Roerich of League of Women Voters compiled an excellent set of notes on the event. A reporter from the Winona Post was present at the event and did speak with people afterwards, but there was no article in the paper. In the future, the committee may submit a press release for publication following the event. Given the positive feedback, this event will continue to be one supported by this committee.
- **Restore the Vote & 2<sup>nd</sup> Chance Press Conference:** Karin spoke at a Restore the Vote & 2<sup>nd</sup> Chance Press Conference at the Capitol on behalf of the Minnesota County Attorney's Association (MCAA). The proposed legislation would restore voting rights to persons who are convicted of a felony, but who are no longer incarcerated. The legislation was co-sponsored by Tony Cornish and Steve Drazkowski and has bipartisan support. It is endorsed by the MCAA, Minnesota Corrections Agents and League of Women Voters, among others. The proposed legislation modeled after similar legislation that has been in effect in North Dakota for several years. Studies have shown the legislation reduces recidivism because persons who are not disenfranchised feel like they are more a part of the community and less likely to engage in criminal behavior.
- **Individual Meetings with Legislators:** Karin and Fatima both secured individual meetings with area legislators during recent trips to St. Paul. Fatima spoke with Representatives Drazkowski and Pellowski, along with Senator Miller. Rep. Pellowski suggested that Fatima speak to the local Chamber of Commerce about supporting the drivers' license reform legislation. Karin also spoke with Senators Miller and Schmitt. Fatima and Karin will follow up with Della Schmidt of the Winona Chamber of Commerce regarding support for the drivers' license reform legislation.
- **Answering the Voices Community Dialogue:** Fatima received some calls following the event about possibly pulling together a booklet for immigrants with basic information on the justice system. She was directed to contact the Attorney General's Office to see if such a book was already in existence.

## **Upcoming Events-Planning Status:**

- Legislative Outreach: The Immigrant Law Center has asked the CJCC for another letter of support for the drivers' license legislation. Karin has a copy of the letter that we sent previously and will talk with Sheriff Gannrud about signing onto the letter.
- WCAO Crime Victims' Rights Week: Manire Vaughn, an intern at the Winona County Attorney's Office is working on organizing several events for Crime Victims' Rights Week, which is April 19<sup>th</sup>-25<sup>th</sup>. He is collaborating with interns from the WRC and Project FINE for one of the events. Stay tuned for more information and requests for assistance/participation by CJCC.
- Law Day 2015: Law Day is set for April 30<sup>th</sup> (Winona Middle School) and May 1<sup>st</sup>, 2015 (outlying schools). Winona Middle School has 200 students, while the following outlying schools have the following number of students: St. Stanislaus (3), Lewiston-Altura (41), Riverway Learning Community (9) and Immanuel Lutheran School (18) and St. Matthew's (15). Stephanie will update the script to incorporate a longer trial, as the jail tour will be replaced by the jail video. Kalene will contact the schools regarding transportation needs, schedules and number of classes per grade. The pre-Law Day duties were discussed, with several individuals being mentioned as possible candidates to deliver the pre-Law Day message.
- Winona County Fair: The County Fair is July 8-12, 2015.
- Community Collaboration Summit: The Summit will again be held in the fall—likely September.

**Call to Order:** 12:00 p.m.

**Approval of Minutes:** Minutes of February 18, 2015 meeting approved without changes.

**Immigrant Driver's License Bill:** Fatima and Karin will be meeting with Winona Chamber of Commerce Executive Director Della Schmidt this afternoon at 3:00 p.m. to request support for the driver's license bill. The Minnesota Chamber of Commerce is already supporting the effort. At present, authors are still being gathered for the bill and it has not been scheduled for a hearing.

**State of Using:** CJCC is one of several sponsors of two showings of the "State of Using," which is a documentary created by Minnesota youth which details how substance abuse has impacted their lives. The showing will be followed by a panel discussion moderated by Karin Sonneman and featuring Ron Ganrude (both); Todd Hoffe (both); Lynn Theurer (Winona) and Joe Morse (Lewiston) and Mark Dungy (both).

- **Drug Free Communities (DFC) Grant:** Kalene updated the committee on the recent DFC grant submitted by the Winona County Alliance for Substance Abuse, whose fiscal sponsor is Winona Health. ASAP's principle mission is to use community collaboration to reduce youth substance abuse in the community. The grant would provide five years of funding for a coordinator to coordinate those efforts and for program and office expenses. The Action Plan that was developed contains some of the same strategies that were considered, undertaken or endorsed by the Crime Prevention Committee. Kalene is on the ASAP Steering Committee and she and Janneke Sobeck (from Livewell Winona) provide regular updates to the Crime Prevention Committee. Some of the strategies on the Action Plan will also involve media and public outreach, so ASAP may look to the COD Committee for assistance.

**WCAO Crime Victims' Rights Week:** Interns from the Winona County Attorney's Office and WRC of Winona are collaborating to plan several events for Crime Victims' Rights Week, which runs from April 19<sup>th</sup> to April 25<sup>th</sup>. Multiple events are in the planning stages, including a Human Trafficking Presentation at WSU; a "Night of Survivors" event and a Financial Exploitation Presentation at Benedictine Adult Day Center. Stephanie will post more information about the events as it becomes available on the new, WCAO's Facebook page.

**Law Day:** Kalene distributed a summary of contact persons, bussing needs, event times and participants. She also brought samples of the Law Day pencils, brochures and other promotional items she got from the American Bar Association. Kevin Kearney will coordinate the pre-Law Day program with each school. Stephanie spoke with Cory Hanson about the content of the

Mock Trial and other details related to Law Day. Committee members prefer to give the students who do not have speaking parts a general overview of the trial, as opposed to having them read through the scrip. Stephanie will have the script completed by the end of March/beginning of April and get it to Kevin, who will provide it to the schools. She will also provide Kalene with any needed updates to the Law Day Brochure. Kevin will distribute the Law Day Brochure, pencils, scripts (and speaking parts) and jail videos to the teachers when he does the pre-Law Day program. He will also coordinate the busses for the Winona Middle School. Given the number of chaperones and the willingness of the WCAO interns to serve as tour guides, we will only need a limited number of tour guides.

**Disproportionate Minority Contact Report:** La Crosse County completed an analysis and received a report regarding disproportionate minority contact with the criminal justice system. Chuck Ripley of WSU would like to know if anyone from Winona would like to attend the training that will be held in La Crosse regarding this issue. Apparently, Dr. Stephen West plans to attend, leaving one slot available. Since it was unclear to the committee as to what type of training was being offered, Karin will seek clarification from Chuck Ripley.

- **WSU Presentation on Race, Policing and the Criminal Justice System:** On March 24<sup>th</sup> at 7:00 p.m., Nekima Levy-Pouds of the University of St. Thomas will give a presentation at WSU on Race, Policing and the Criminal Justice System.

**Approval of Minutes:** Minutes of March 18, 2015 meeting approved without changes.

**Upcoming Events-Planning Status:**

- **Crime Victims' Rights Week Events:** Karin distributed a schedule of the multiple events that are scheduled to take place during Crime Victims' Rights Week (April 19<sup>th</sup>-25<sup>th</sup>). Interns from the County Attorneys' Office, WRC and Project Fine collaborated on the planning of several of the events. Members were encouraged to attend.
- **Law Day:** The Law Day brochure has been revised and printed for distribution by Kevin during his pre-Law Day programs at the schools. Stephanie and Carmaine are working on finalizing the mock trial script. Lynn will solicit volunteer tour guides from the League of Women Voters; County Attorneys' Office interns will also act as tour guides. The schedule was discussed and the defense attorney station was changed to accommodate the judicial interviews which will be taking place on those days.

**Other Events and Matters to Discuss:**

- **County Fair:** In the past, the committee has shared space and attendant duties with the Sheriff's Office. Committee members expressed interest in continuing to do so. Karin will contact Sheriff Ganrude about shared space/duties.
- **Driver's License Bill:** Fatima and Karin met with Winona Chamber of Commerce Executive Director Della Schmidt to request support for the driver's license bill. They had a lengthy conversation about that issue and others. Ms. Schmidt took the request for support to her board but they declined to support it as it was not consistent with their current agenda. Sally heard that Governor Dayton stated that would sign a bill that allows Minnesota to issue driver's licenses to unauthorized immigrants. Kalene will follow up with Felipe Illescas of the Immigration Law Center to determine the current status of the legislation and need for additional support.
- **State of Using Presentations:** State of Using presentations were held at Lewiston and Winona schools last month and were well attended. The presentations included a movie about youth drug/alcohol use in Minnesota followed by a panel discussion. The main sponsor of the group, Alliance for Substance Abuse Prevention, submitted a Drug Free Communities grant application last month. Pending notification of funding, the Action Plan that was developed as part of the grant will be shared with the CJCC Crime

Prevention Committee (which has previously undertaken many strategies aimed at substance abuse prevention in youth) in the hopes that the committee will start working on some of the Action Plan strategies.

- **Recovery Is Happening**: Recovery is Happening sponsored two listening forums (one in Wabasha and one in Rochester). The group is grant-funded and led by a Wabasha County drug court graduate. The event consisted of having drug court graduates and participants and people in recovery sharing their stories with a panel consisting of judges, law enforcement officials and prosecutors. The panelists then provided feedback.

Sue Abderholden, Director of NAMI Minnesota was suggested as a keynote speaker. If the date and time were selected soon enough, Helen could advertise the event in the Community Education brochure. Helen can also use the public school facilities free of charge if her organization co-sponsors the event. She can also issue Continuing Education Units for educators. Mental Health Awareness Week is the first full week in October (5<sup>th</sup>-9<sup>th</sup>). Helen will contact Ms. Abderholden and the schools to determine availability. A workgroup will be formed to plan this event. (NOTE: Ms. Abderholden is available on October 8<sup>th</sup> and the schools would be available from 6-8 p.m. that evening, so the event is tentatively scheduled for October 8<sup>th</sup> from 6-8 p.m. at the Winona Middle School).
- **Legislative Updates:** Helen reported that the legislature authorized additional funding for mental health this session. Neither the driver's license bill, nor the "restore the vote" legislation passed this session; both will be introduced again next year.

- **Mental Health Roundtable with Senator Al Franken:** The Roundtable was held on July 2, 2015 at the Winona County Historical Society. The Winona Daily News had a front page article on the event and the Winona Post is expected to provide additional coverage as the work of the Stepping Up Initiative Workgroup progresses. As a follow-up to the roundtable, Helen noted that the Tri-County Mental Health Committee is working with law enforcement to bring Crisis Intervention Training (CIT) to the communities it serves (Houston, Wabasha and Winona).
- **Winona County Fair:** CJCC helped staff the Sheriff/DARE/Towards Zero Deaths “booth” at the fair from July 8<sup>th</sup>-12<sup>th</sup>. The “booth” was actually the mobile command center with canopy-covered tables and was located in the middle of the fairgrounds, across from the fair office. The format was comfortable and accommodated the Kids ID program quite well. However, because of the multiple organizations represented, it was sometimes challenging to display educational materials and to interact with fairgoers as much as in past years. The Super Gav Dunk Tank was an entertaining distraction/attraction as it was located adjacent to the booth.

- **Fall Summit:** The Community Collaboration Summit on Mental Health is scheduled for October 8, 2015 from 6:30-8:30 p.m. at the Winona Middle School. **Elected Officials Forum:** The forum is scheduled for January 16, 2016 starting at 9:00 a.m. at the Winona History Center. The League of Women Voters will again co-sponsor the event. League President, Stephanie Nuttall, will moderate. Thus far, Lynn has received commitments to attend from the following elected officials: Representatives Gene Pelowski and Steve Draskowski, Judge Leahy and Karin.
