

LEVELS AND TYPES OF SENTENCES

- Executed Sentences
- Misdemeanor up to 90 days jail, up to \$1000 fine
- Gross Misdemeanor from 91 365 days jail, up to \$3000 fine
- Felony 12 months and 1 day to life without parole
- <u>Stayed Sentences</u>
- Misdemeanor typically up to 1 year
- Gross Misdemeanor typically up to 2 years
- Felony 3 years to 40 years **

PROBATION - FROM REFERRAL TO DISCHARGE

- Referral from County Attorney's Office or Courts; Release from Prison
- To Diversion, Probation or Parole
- Intake
- Risk Assessment, other assessments Domestic Violence, Psycho-sexual, Chemical Use, Mental Health, Trauma
- Pre-Sentence Investigation Report or Pre-Disposition Report
- Sentencing or Disposition
- Probation Agreement and Case Plan
- Monitoring Conditions
- Progress Reports
- Violation Reports
- Discharge Reports

SUPERVISED RELEASE (PAROLE)

- A supervision status that occurs after being released from a juvenile or adult correctional facility (prison).
- In MN, as an adult any executed sentence consists of a term of imprisonment (2/3 of the sentence) and a term of supervised release (1/3 of the sentence)
- A violation of supervised release can result in a restructure (lesser sanction other than prison) or a revocation in which case the offender returns to prison for any or all of their remaining sentence.
- Hearings and Release Hearing an HRU officer (not a judge) who hears release violations and determines appropriate sanctions for those on supervised release

TYPES OF CONDITIONS THAT ARE MONITORED

- Short term jail less than executed sentence
- Short term prison less than executed sentence
- Electronic Home Monitoring
- Electronic Alcohol Monitoring
- GPS
- House Arrest
- Curfew
- Assessments/Evaluations
- Counseling/Treatment
- Cognitive Skills Programming

TYPES OF CONDITIONS THAT ARE MONITORED CONTINUED

- Treatment Court, Veteran's Court (there are other specialty courts outside of Winona County including Mental Health Courts, DWI courts, Family Courts)
- Attend Victim Impact Panel
- Community Service
- Employment
- Education
- Drivers License
- Parenting Classes

TYPES OF CONDITIONS THAT ARE MONITORED CONTINUED

- No contact
- No trespass
- No enter
- No associate
- Drug/Alcohol Testing
- Searches
- Pay fines, fees, and restitution
- Maintain contact supervising agent
- Keep supervising agent informed of current contact information, residence, employment, school

SANCTIONS V. FORMAL VIOLATION

- Supervising Agent's Informal Directive
- Probation Sanction or Parole Restructure
- Revocation of Probation or Parole

INTRASTATE AND INTERSTATE TRANSFERS

- Intrastate Supervise probation or supervised release (parole) for another county
- Interstate Supervise probation or supervised release (parole) for another state
