  - From Dave: how it will work to get people signed up to do programs:
  - It will be a lengthy process to get volunteers started in the jail- need background check, training etc. Dave G. had mentioned that volunteering in the new jail won't begin until September 2023, but we may need a lot of lead time to get everyone trained. We will need structure to to keep track of things
  - Background: two jail staff who do background checks
  - Program Coordinator/training officer: will take care of all trainings and track background checks etc. Dave G is currently Assistant Jail Administrator, Dave will transition to the Program Coordinator/Training Officer around mid-summer.
  - Will be a complex operation to run the programs in the new jail- lots of moving parts, lots of logistics, we don't want volunteers to show up and not have space or vice versa.

#### **Summary of Workgroup context and purpose:**

Assist in providing a broad array of programming in the Winona County jail by engaging community organizations and inviting their participation.

#### Discussion:

- Dave G: what we are looking for: we want to offer any programming that folks in Winona want to offer and would keep inmates busy. Does not just have to be Bible study AA/NA etc, can be fun/entertaining as well. Inmates going to the rec room is also a program- can be very structured or not so structured.
- Eileen Hanson: what would planning look like for a person who wants to offer a program? Dave G: This can be tricky- the scheduling will be the most challenging part. NA/AA etc are often in the evenings. Once we get applicants in, we will need to start making decisions on who will do what and how it will work. The volunteer applications are available at the front desk now if anyone wants to apply. Eileen: What kind of numbers would each program offering have in attendance? Because of the classifications of people in the jail (13 classifications in new jail). Where the jail houses someone and how they are classified will affect where someone can attend programs- can't mix classifications. Zoom will be utilized quite a bit but Dave G thinks that in-person programming is better.
- Tara: Do people offering programming have to be off of probation? Need to have not been 'in trouble' for at least two years- can still be on probation but there are certain charges that exclude individuals from providing programming. Dave will also screen for people who may be easily manipulated to break rules etc.

#### **Review of Purpose** (as agreed to at 2/27/23 meeting)

County staff Liaison - Dave G has resigned his position ... County is currently seeking to hire for the jail programming position.

Please share an invitation to the group, and let Rachel know if anyone who you think should be included in the Jail Programming Committee.

#### Agenda:

**Jail programming staff update:** Dave G has resigned. Who will the jail programming committee work with moving forward? For now, Steve Buswell will be the contact until the programming staff position has been filled.

#### **Jail Tour update:** CJCC toured the jail last Wednesday

A lot of space for programming, many spaces and structural support for programming opportunities. Committee will need to be mindful of staff logistics in planning programs. Could do in-person in one area, with a virtual option from a different area of the jail to maintain separation of inmates of different classifications.

Each inmate will have access to a tablet, for keeping contact with loved ones, accessing their paperwork, making any complaints, and accessing approved materials, e.g. GED texts or other programming materials.

**"Tier 1" programs -** programs that have been offered in Winona County, and are offered in many places already. E.g. NA/AA, GED and vocational training, Bible study or religious gatherings, HUBER work release program.

HUBER work release - allows inmates to continue at a job or find work, or go to school with restricted access to any other activities during release. Staff works to maintain relationships with employers. Transportation is not provided by jail staff. Stuff now uses a GPS unit (at inmate cost) to track location while out on release.

Mike Kuehn - are people on work release in separate housing? Sheriff Ganrude - don't know at this point

Mike K: could we offer assistance with job search and logistics? It would be easier, more efficient if individuals approved were housed in the same area, as with the previous 'Annex'.

Kelsie: They will determine what makes the most sense in terms of logistics and how many inmates are approved, if it makes sense to reserve a housing unit (or two) specifically for those approved for work release

Teen Challenge - 15 hrs/wk, considered "outpatient" treatment while in custody. One-one meetings with individuals and substance use treatment programming.

# Educational opportunities? (question form Maurella C) -

Mike K: community college programs have been offered in other facilities

Pathways to Prosperity program - Chris D - in-house options:

Welding, CNC classes

E.g. Olmsted and Goodhue programs offer manufacturing 101 for college credit- can be completed entirely during incarceration

Working to expand offerings in Winona

Releases can be arranged for educational opportunities - Kelsie has worked with college students to be able to complete coursework

What about Continuum of Care? (Maurella C): How are people bridged to continue such opportunities around transition out of custody

Katie - WRAP offers this

# What might we learn from neighboring counties and how they offer programming?

Best practices research?

Jay Palmer: Project Proven which has work with the La Crosse jail for a few years. Jay is happy to reach out to them.

Maurella C: OJJDP may be a good resource re: best practices.

\*OJJDP is the Office of Juvenile Justice and Delinquency Prevention. Though the jail will not have juveniles, there is some very good information re: programming on the OJJDP site.

- Thinking about how to bridge people who encounter programming while incarcerated to similar programming (a friendly face, familiar context) once they are released.

  - Employment resources: DEED can assist (Marleen Lundberg)
  - Jail Social Worker can provide referrals to community agencies thru WRAP+

Resource list, sign up for court reminders (text/email), HUB referrals for those that do not qualify for WRAP+ that would like to work with someone to access resources/navigate barriers post release, food, coordination of substance use assessments, and shelter options. Currently qualifying individuals in custody that screen for WRAP+ services get the above-mentioned things as well as coordination for mental health assessments and may work with jail social worker up to 60 days post release until a warm hand off can be made to another community provider that may work with the individual longer term i.e., HUB, ADM-TCM, ARHMS, ect.

# **Update: Leveraging community partnerships:**

Chris Dahlke reached out to SE Tech: continue employment training classes in the jail, developing a way to take college level classes prior to GED completion, hopeful to keep this communication on-going and develop new opportunities Justin Green - has spoken to pastors in town who are willing and supportive - believes that it would be beneficial to develop program plan, and then recruit volunteers

Tara Brown - CMA/NA/AA people are eager to get involved

# Sgt. Kelsie Horst:

Applications for jail programming volunteers, with background check - can get started ASAP. County has an existing application, which should work.

Applications can be picked up at Sherrif's Dept, or complete digital version. Sgt Horst will send digital copy to this committee.

Completed forms can be returned at Sherrif's dept or email to Sgt Horst.

Currently working to schedule the programming in terms of Treatment with Teen Challenge, and then will reach out to Tara and Justin to begin scheduling CMA/AA/NA and Bible Study.

#### **Funding Update**

 Funding from CJCC or WRAP+: Kalene Engle manages the grants that provide the funding.

Update that follows is from Kalene Engel and groups discussion:

- Current WRAP+ can access pools of funding in various categories. All on the WRAP+ website <a href="https://winonacountycjcc.org/wrap-forms/">https://winonacountycjcc.org/wrap-forms/</a>
  - Link for Instructions Excerpt from Policy and Procedure manual (PDF download) lists categories of available funding
    - Tier 1 funding for people not quite full participants in WRAP+ - limited funding, mostly for assessments (mental helath and substance use disorder), and small amount for monitoring services
    - Tier 2: people who meet the criteria and have done MH eval
  - Money not given direct to participant, therefore no gas cards are available as that is considered a direct payment
  - \$2,000 per person cap
  - Other things are available at times;
    - Got some free laptops from WSU for participants
    - Some bikes available
  - Cognitive/behavioral skills education was avail in the jail pre-construction... want to bring this back

- Funding is not unlimited ... Kalene Engel has requested an extension, ideally funding will run through June of 2024
- Note that this is a mental health grant, so spending must broadly meet this need.
- Winona County is in our second round of this grant .. can try for a third. If we apply and are awarded a third round, funding would be available probably October 2024.
- If there are priorities that will require more funding .. Kalene needs to know by the end of May in order to submit budget modification request. Needs to know if there are new/differnt program categories .... money is already available for on-going participant expenses like ID's, etc.
  - Do our priority programs (AA/NA/CMA, treatment, and bible study) need any funding?
  - Education opportunities do those require any funding?
    - P2P grant classes no additional funding needed
    - GED services can be provided free
  - Per discussion, our top program priorities seem to be covered at this time.
- WRAP+ can really only fund needs of people in the program due to constraints of federal grant requirements.
  - SW, Katie whose position is funded by WRAP+ money helps people fill out application, and refers to other resources if they don't qualify, or choose not to enroll ...but otherwise WRAP+ can't assist people that don't qualify or enroll

- Tara has started handing out applications for NA/AA and noticed that there is not a question of how much clean time a person has had on the application- does the jail have guidelines for clean time? It used to be that a person could not be on probation anymore, but that has changed- now people just need to be in good standing with probation. Tara wants to ensure that recovery community is aware of guidelines so that people do not turn in applications who will not be accepted. Rachel will pass this question along to jail staff
- Sgt. Horst had to leave the meeting and is unable to give update on applications,
   Rachel will email her and add her response to the end of these notes.

#### **Jail Tour for Jail Programming Workgroup:**

- There is interest in a jail tour: looks like 4+ people are interested
- Should this be done in lieu of a meeting or at a separate time? No major preference in group- we will defer to jail staff on scheduling
- Rachel will reach out to Jail administrator and schedule a time and will send out to this group first and then forward on to other CJCC groups if there is room

#### WRAP+ Update:

- WRAP+ was granted a no cost extension and can operate until they run out of money or September 2024, whichever comes first.
  - This will benefit people being held in the Winona County Jail who qualify for and agree to participate in WRAP+
  - This is also funding that supports the Jail Social Worker (CJCC is working to make a proposal to make this position permanent, but it is not guaranteed past the WRAP+ grant period)
  - WRAP+ trainings
    - Rachel will send out with minutes
    - There are trainings that are recorded and available on CJCC website (WRAP+ and other trainings) <a href="Trainings-Winona County Criminal Justice Coordinating Council (winonacountycicc.org">Trainings Winona County Criminal Justice Coordinating Council (winonacountycicc.org)</a>
- Further funding- difficult to write a new grant for additional funding past 2024 but could not write those when we still have a lot of money in this grant. Grants are generally posted in March and Kalene will look at that once it is posted to see if we should apply for more

Note from Sgt. Horst about applications to volunteer at the jail (sent after the meeting since Sgt Horst had to leave the meeting early):

"Currently I have three volunteer applications and I am screening them all.

One for each of the following programs:

- CMA
- NA
- Financial Classes

The guidelines I am following for volunteer acceptance is this:

- 3 years since last offense date / 3 years sober
- Will run you for probation.
  - If on Probation I will be contacting probation officer to check on your standings and progress.
- If I am not familiar with you or have not met you personally I will set up an in-person meeting prior to a decision being made.

You are correct, previous applications never had the last offense date/ sober time question on the application, and I think I will add the clean time on the application going forward.

If someone meets all the requirements except they have not met their anniversary date for 3 years since last offense/sober time, they will still be eligible to take the required training to be a volunteer and once that anniversary date arrives, they will be eligible to begin volunteer work if they are in compliance with everything we require.

I am currently working on revamping the volunteer handbook and required trainings needed PRIOR to being allowed into the facility to volunteer.

I do NOT want people's anniversary dates from last offense or sober time to deter them from applying to be a volunteer, but it will play a part in my screening process."

### Rachel's thoughts on going forward:

Based on Sgt. Horst's note, it looks like we need to do a fair amount of recruitment of community members to fill out applications to volunteer in the jail and it looks like we could recruit for all programs.

  - Inmate count: 19 today
